I recently splurged and bought myself a new Elecraft KX-3. Because of that I need to reduce the surplus of QRP rigs in my collection. I am offering my Elecraft K2 and my Wilderness Radio Sierra/

The K2 is a 5 W (more on some bands) 160-10 rig. It is 8" wide X 3 1/4 tall by 8 1/4 deep. It has both CW and SSB modes, and is wired for a Kenwood 8 pin mic connector. I honestly only used it on CW and it worked great on that mode. I am not a SSB operator, but it does work with voice. It has built in antenna tuner for 2 antennas, and also a separate 160 receive antenna input, if you wish to use it there. In addition it has multiple bandwidth filters and a built in memory keyer. I would like \$300 for this radio.

The Sierra is a nominal 3 W CW rig, with plug in modules for 80, 40, 20 and 15m. It has a built in keyer, and variable bandwidth audio filter. I would like \$75 for this radio.

Amateur RadioTest Session Requirement.

If you are going to take a test session for either a new or upgraded ham license, here are a few things you MUST bring along.

A copy of your current FCC license. We need to attach the license copy to the paperwork when you upgrade. If you are unlicensed, the FCC form 605 requires a FRN. You can obtain a FRN in just a few minutes before the exam session by visiting https://www.fcc.gov/wireless/systems-utilities/universal-licensing-system You simply apply for the FRN on line, and you will have it with you when you come to the test session.

Another form of ID, a driver's license is great, or any other form of ID. If you don't have a driver's license, (perhaps you are too young for the DMV) the ARRL suggests something as simple as a library card, or even a piece of mail addressed to you at your residence.

A pen and pencil (with a good eraser). The pen is for filling out the FCC form 605, and the pencil is to fill out the bubble answer sheet.

The proper testing fee. Currently it is \$15.

Your WITS. It is not a hard exam, so don't get too anxious about it.

Please arrive at least 15 minutes before the exam start time in order to fill out the paperwork, and for the VE's (Volunteer Examiners) to review it.

Another thing to bear in mind, is that for many of the testing sessions, the VE team will have alternate versions of the various exam elements available for you to try a retake of the exam. If you do desire to take an alternate version, we must you charge you an additional testing fee. If you DO NOT NEED to take any alternate versions, you may take the next higher level of exam for NO additional costs. For example, if you take and pass the Technician exam, you may take the General exam if you so desire, and there will be no additional fees. I have witnessed a few people who have come into the session unlicensed, and walk away with the Extra Class license.
